Treasurer's Report

Tim-

Profit/Loss

Everything is recorded with the exception of the new registration, which does not affect the Profit/Loss. Philmont has lost of \$1518. We have money coming in. It should be about \$400.00 loss. There is a \$300.00 discrepancy on the books. Fishing trip - \$250 goes to Lance to make-up for what he paid out of pocket. Kayak trip- \$300 from this trip has to cover Philmont. Funds are consistent with Scout awards. Hometown fair- Sales were about \$8800.00 Scout award fee- supplies/awards/recognitions.

Balance Sheet- only includes PayPal transactions. Checks have not been recorded yet. There are several checks between Alan and Tim that will be an additional couple thousand dollars. Michael is requesting donations for Scout House. Possible available funds: retained earnings, net income, Eagle Scout fund, New friends \$5600.00. Scholarship fund is not.

History- we started to ask for donations. Fund started called Friends of the Troop. The donations were not tax deductible. We started a 501c3. Now the funds are deductible. Tim's determination- this money is now available for donation. Wide open funds. Eagle Scouts fund is for overfunding for eagle projects that need extra funding. Tim's assessment is that we have plenty of money for the money that Michael is asking for.

Don McClellan and Michael started this fund along time ago. They started a friend's fund. Kurt Keterer started a corporation of Troop 849-501c3. We did not meet the guidelines to continue to be a 501c3. So we closed it out. The funds were tax deductible at that time. We are looking at \$14000.00 It is not the intention to empty the coffers. Scouts that cannot afford activities, talk to Hugo. Hugo can underwrite the payments for the Scout. Underwriting is confidential.

New Scout House

The new Scout House ...we need \$250,000 to break ground. The building is going to be city owned. We are looking to build the Scout House. Michael is willing to discuss the purpose of the Scout House. We are going to be involved with the older people, girl Scouts and Cub Scouts. There is a committee that is Michael is on that is leading/building the new Scout House. Michael is asking for \$14,000.000 Why \$14,000? Because that is what the friends fund? Because that is what we have available. The number is out of the half. We have an operating budget of \$8000 a year. We are a shareholder of the new building. We will have use. This supports the troop. We are going to have a better building. What are going to do for the time we don't have a space. We do the burger booth every year. At the Hometown Fair, why was there not a booth for money for the Scout House. Question? Is the money to spend today? Or is it a pledge?

If we give \$14000-, is it taking half of our available cash? No. It is different accounts. The burger booth is a real cash cow for us. In the past we had a real hard time to break even for the troop. The burger booth is a single point succeed/fail point. Troop 849 is one of the biggest beneficiaries of the new Scout House. Our kids are never going to see it. Tim has the first \$500,000 into the new Scout House. He has another \$250,000 for matching money. That fund is not appropriate for a match with the Scout money. The Friends Fund was to cover the cost of customizing the space for our troop space. What about pledging the money at the end to make the Scout House finished for the troop? Harry is cynical that building is going to finish timely. How to show that there is troop commitment? We need to have matching funds. We are the only group that has lockers on both ends of the current Scout House. The current Scout House needs to have at least the current capabilities we have now. We all support this project. The enthusiasm and passion comes from the details over the how, what, and when details.

Motion to pledge \$10,000 to the new Scout House. This pledges includes the promise to develop and implement a matching fund component for a total donation. Committee wants guidance from Tim's fund raising team. Do we need publicity for Troop 849 from this large cash contribution?

"Fund Me" Kick Starter

Tim and Michael have recused themselves from the vote.

Friends of Troop 849 are the sponsoring organization/ Hugo asked for a troop constitution or bylaws. No ones have ever seen it.

The committee is empowered to make the decision now.

Hugo tabled the discussion for 60 days.

Hugo wants to include the prior committee chair: Michael McClellan, Dick Rose, Kurt Ketterer and entire prior committee. Michael and Tim will be included but not vote. The committee will come up with a consensus. Hugo wants the decision to beyond reproach. He wants everyone to donate.

Is the name of the building set? Is the new building going to be called the Scout House? There is MOU with the city. The community can only use it with a 30-day notice. This is a huge advantage for the Scouts. The seniors can use the entire building while the kids are in school. During the summer, the seniors go back into the 1000 square feet. The Scouts get priority use over the rest of the building. To the extent that the Scouts are not using the building, the seniors can use the building. If the building is not being used, then is open to the community. For every dollar we get from the city they extract two dollars of control. The building is going to go and we need to negotiate what we want. The troop wants to have storage space but the problem is that the girl Scouts are going to want storage space as well. The troop expects that Tim and Michael will defend the interests of the troop. Hugo would like to authorize the subcommittee to make the vote. Subcommittee should have a written proposal and committee will make vote.
